### Introduction

We are pleased to submit the 2014/2015 Annual Report of the William and Nancy Budd Scholarship Fund. This report is unique in several respects. First, it includes the voice and perspectives of our scholarship students and our administrator, Grace Muthungu, emphasizing the importance and impact of the Fund. Second, it lists the more than 70 students that have continued to university and technical training under the program, more than half of all the students we have supported since 2000. They are training to be doctors, teachers, engineers, scientists, technology specialists, farmers and entrepreneurs. It is a significant accomplishment. Third, the report covers a two year period, reflecting the unsettled environment of the past two years that has affected the number of students supported and the funding we have requested. We hope you will agree that the story continues to be inspiring and compelling.

# Report by Grace Muthungu Budd Fund Administrator Senior Program Officer, National Council of Churches of Kenya

The National Council of Churches of Kenya (NCCK) continued to support bright students to pursue Secondary and Tertiary Education. The students are drawn from needy families who may not have adequate funding to sustain continuous education, which has been a challenge in Kenya. While the Government of Kenya is committed to finance secondary education, the amount provided to each student per term is Ksh10,000 (\$100) against a total cost of Ksh90,000 (\$900) per year on average per student. This has caused many drop outs or interrupted studies making it difficult for the students to perform well.

The NCCK works with churches and County Coordination Committees at a local level to identify needy students who are bright and show promise. Once selected, the students are assisted with school fees starting in Form 2 (second year of secondary school). In an effort to promote ownership, the NCCK does not pay the full cost of school fees. The assistance that NCCK provides is guided by criteria which recognizes that different categories of schools charge different amounts. This is usually clarified during admission to the scholarship program. The students are also encouraged to improve their performance and report cards are shared after end of each term. This is in an effort to encourage students to improve their performance as most of them are admitted to the program when they are about to give up. The NCCK works through nine regional offices and students are assisted at that level for ease of follow up.

The Kenyan School Calendar has three terms: Term 1 (January to April), Term 2 (May to August), and Term 3 (September to December). The Kenyan education system requires students to pay fees to the schools they attend. The school fee amounts required for different categories of schools vary from Ksh20,000 to Ksh60,000 (\$200-600) per term. To encourage ownership and participation of the parents, guardians and students, NCCK developed criteria to pay a portion of school fees for sponsored students as analyzed below:

This translates to a total scholarship amount of Ksh45,000.00 (\$450) for students in National Schools and Ksh32,000 (\$320) for students in Provincial schools. Previous experience has shown that parents and students take more responsibility when they have to pay some amount. In some cases students and their families may not be able to meet the balances after the scholarship amount and Government amounts. The NCCK is flexible to meet the balances in these cases.

Most of the students are admitted to the program when their performance in school is still poor since most are either day scholars or cannot attend school because they have not paid the school fees. Once admitted to the program, the NCCK endeavors to mentor the students and work with them to ensure they have adequate support. This collaborative approach has yielded great results and the students improve greatly by the time they reach the National exams. It is encouraging to note that most of the sponsored students achieve good grades which qualify them for direct entry at National Public Universities. Direct entry means that they have the opportunity to pursue courses of their choice at a lower fee; and in addition to this they qualify to apply for a soft loan which is secured from Higher Education Loans Board. Most of the Budd scholars are able to access this loan and they do not require large support from NCCK Budd Scholarship program, unlike in the past when most of the university fees were paid for by the program.

In 2015, 16 students were supported in Secondary schools. The 16 students were drawn from the nine regions of the country. Effort is made to ensure there is equity among the boys and girls, hence 8 girls and 8 boys were beneficiaries during the period. More students have been selected in January 2016 and will start benefiting from the program in 3<sup>rd</sup> term 2016. During the same period, most of the university-level scholars had received recommendation from the NCCK office for consideration of loans as they pursued their university education. Most of them received adequate amounts to cover their costs. The NCCK office is able to establish how much each student is allocated by the Loans Board to ensure that no more than the balance of unpaid university costs is provided by NCCK. Seven scholars did not have adequate amounts to cover all their costs hence these were sponsored with the amounts needed to meet any gaps. This has reduced the amounts being paid from NCCK to the university. Access to the loans is the result of good performance on the national exams upon completing secondary school. The students' good performance may be attributed to smooth learning and continuous support from NCCK and the other scholarship students which NCCK is committed to continuing.

Some of the students were visited at home. Their homes represent humble backgrounds and their appreciation for life and scholarship assistance was evident. Some of the students who were visited had great appreciation and kind words to say regarding where this scholarship has brought them from. Their stories are forwarded as a separate document (Attachment 9 of the Budd Scholarship annual report).

Working with the students from these humble backgrounds and accompanying them to transform their lives has a great impact. This has been witnessed during national or regional retreats that NCCK organizes for the scholarship students. The students have become mentors to one another. Their commitment and stamina to be the best in spite of their different circumstances is an encouragement to those of us who work with them.

A National Retreat is planned at the end of 2016 with the aim of bringing together the Budd scholars who are currently working. The journey from where they came from to where they are now will be documented in an effort to encourage others who may be in difficult circumstances to gain insights on the power of positive thinking and personal commitment to change their situations regardless of the challenges.

It is important to appreciate the Government of Kenya for providing funds that cover the partial cost of educating all students in secondary school. This in turn reduces the burden of school fees on students and their families. NCCK continues to meet the gap of the very needy who would otherwise become drop outs if the intervention was not in place.

The NCCK is indebted to the Budd Scholarship partners who have been instrumental in our work to contribute to improved livelihoods for these students. We have seen firsthand that the students become self-reliant and independent as a result of the opportunities that the Budd Scholarship provides them. These traits are clear indicators of success for these young people.

# 2014 and 2015 Highlights

<u>The Education Environment in 2014-2015</u>: The past two years have been an unsettling environment for the education system in Kenya and for the Budd Scholarship Fund. The new Constitution of Kenya instituted a major system of devolution. Nine provinces were abolished and converted into 47 new counties which were given significant new responsibilities for the delivery of public services. While education was not decentralized, the new counties were given additional responsibilities for managing the school system for which many were unprepared. At the same time, the government instituted a policy of financial support for secondary schools but lacked the funds to implement the policy. The actual amount of funding provided varied widely from county to county and school to school.

Simultaneously, our long-time administrator of the Budd Fund in Kenya, Grace Muthungu of the NCCK, was given new responsibilities to deal with the refugee crisis in Kenya (with more than 600,000 refugees from Somalia, South Sudan and elsewhere). While it was recognition of Grace's capability and commitment, it also came as a surprise to the board. Grace promised that she would continue to keep a close watch on the program, but it was difficult to for her intercede in the program that was no longer her primary responsibility. Moreover, as Grace has indicated above, the most promising students pursuing post-secondary education have achieved such high grades they are enrolled tuition-free or have access to low interest loans, reducing the need for funding by the Budd Fund.

The result of these many changes and uncertainties was a hiatus in the program. No new students were recruited in 2014 and no new funding was requested from Budd Fund contributors in 2015.

The situation has now stabilized and the Budd Fund Board has decided to reinvigorate the program in the coming year. Some highlights of the restart are described in this section.

**Student Enrollment:** The Budd Scholarship Fund is entering its 17th year in 2015. Over its lifetime, it has supported 136 students from needy backgrounds with academic promise and exceptional character—optimistic and caring for others even as they face their own challenges.

In 2015, the Budd Scholarship Fund supported 23 students—7 in post secondary education and 16 in secondary school. In 2014 the Budd Scholarship Fund funded 30 students—10 in post secondary education and 20 in secondary school. This compares to 39 students in 2013 and 44 students in 2012. Twelve new students were selected in 2015. Their profiles are attached to this Annual Report (Attachment 7).

**<u>Student Achievement</u>**: Student achievement continues to be exceptional.

All sixteen students qualified for national university admission with reduced tuition or low interest loans.

**2015 Expenditures:** Total expenses in 2015 continued to decline compared to previous years. There was a 39% decline compared to 2014 expenditures. This was the result of the decline of 23% in the number of students supported (from 30 to 23). The NCCK reported that some of the decline in expenditures is due to the ability of post-secondary students to receive free or subsidized tuition due to their superior examination results.

**2014 Expenditures:** Total expenses in 2014 declined about 25% compared to the previous two years. This was the result of the decline of 25% in the number of students supported (from 39 to 30), in part due to the lack of new entrants in Form II in 2014 and, in part according to NCCK, due to the ability of post-secondary students to receive free or subsidized tuition due to their superior examination results.

The average cost per student in secondary school in 2015 was \$225, compared to about \$308 in 2014 and \$310 in 2013 (at the 2015 exchange rate of \$1=K shillings 102). The average cost for post-secondary students was \$92 in 2015 compared to \$232 in 2014 and \$248 in 2013. A significant reason for the decline in the US dollar equivalent cost is due to the significant drop in the value of the Kenya shilling vis a vis the US dollar over the period. The names and expenses for each student in secondary and post-secondary education in 2015 are attached (Attachments 4 and 5).

The NCCK plans to continue selecting students each year from each of its nine administrative units, (aligned with the old provinces) each of which provided one Budd Scholar per year (plus the one student from the Kinyoro Primary School near Kitale).

**2014/2015 Contributions**: Fifteen contributors donated \$23,954 in 2014, one less contributor than in 2013. The Balance Sheets and Profit and Loss Statements as of December 31, 2014 and December 31, 2015 can be found in Attachments 1 and 2. \$20,000 was wired to NCCK in January 2014, the same amount as in 2013. Six individuals wired 300 UK pounds in March 2014 as well, which avoids a double exchange rate loss (Pounds Sterling to US Dollars to Kenya Shillings). The individual contributors are acknowledged in Attachment 3. Though funds were not requested in 2015, a few individuals donated to the fund.

**Reserve Fund:** The Reserve Fund was created in 2010 and managed by Doug Platt through an Ameritrade account. The fund increased in value by \$5,405 (7%) in 2014 and decreased in value by \$1,600 (-2%) in 2015. Its value at end of October 2016 was \$80,016.96.

**NCCK Retreat:** The NCCK organized a retreat in November 2014 for past and present scholarship beneficiaries. 65 students and alumni attended the retreat. See Attachment 8 for a write-up and photos from this retreat.

**Fund Administration:** As indicated above, Grace Muthungu advised in late 2013 that she had been given new responsibilities at the NCCK and would be stepping down as administrator of the scholarship fund. She indicated she would stay connected with the students and the program in some fashion and confirmed that Gladys Ndungu and Micah Makongo, the treasurer, would continue to administer the Fund. Despite her new duties, Grace has remained actively involved in the Fund throughout 2014 and 2015, and is likely to stay engaged until she retires from the NCCK sometime in the next few years.

**Fund Management:** The 11<sup>th</sup> Annual Meeting of the Budd Scholarship Fund took place on August 14, 2014 at Encampment Forest in Minnesota. Michael McCarthy produced the 2013 Balance Sheet and P&L Statement and Daniel the 2013 Annual Report.

The transfer of leadership agreed in 2011 has proceeded, with the new board members meeting regularly since November 2014. The funds from the former bank account were transferred to the new account that was opened by the Treasurer, Emily Ballios. Also, an additional payment method, PayPal, was established for donors to provide contributions.

At the 2014 Annual Meeting, the board decided to institute sunset provisions to ensure that students could be fully supported from Form 2 through to the completion of post-secondary study. New students would be supported until 2017, after which time no new students would be accepted.

Having completed the transition activities, the board members are encouraged to focus their efforts on seeking new donors to support the Fund so that new students can be supported past 2017.

At the 12<sup>th</sup> Annual Meeting on August 25, 2015, the Board considered whether it was time to wind down the Fund, support students enrolled as of 2017 through secondary school and post-secondary education and use the funds available in the endowment fund to cover the remaining expenses. At the urging of the NCCK, it was decided to defer any decision regarding the future of the Fund until members of the Board had a chance to visit Kenya for a first hand review. That review is likely to take place in 2017. In the meantime, the Board approved soliciting funding in 2016 for the coming year.

To assist with efforts to seek new donors, one key activity has been to refresh the Budd Scholarship web site. Vice President David Budd added a new design to the site, which can be viewed at http://buddscholarship.org/.

The board members continue to meet on a monthly basis.

<u>Current Status of Students and Alumni</u>: The NCCK kindly provided the board with a list of the current and former Budd Scholars who have remained in contact. The list describes the university that the student attended, the degree they obtained, and current status if known. It is included in the report as Attachment 6. Seventy-five students, or more than half of all students enrolled since 2000, have taken advantage of post-secondary education, pursuing a wide range of academic studies and practical training.

**Program Impact**: Fourteen secondary school students describe what the scholarship program means to them in Attachment 9. They talk about the hope and the promise in the opportunity they have been given.

#### **EFFIE - WD**

Effie was born on 26/7/1999 in Nyando District, Kisumu County to the Gordon Otieno Obado and the late Lucy Apiyo Oticha. She After her mother died, her father resulted to drunkardness, abandoned the children and married another wife. Effie was later adopted by a Kenya Mennonite Church Pastor under whom she has been raised as his child. The Pastor took her through primary since class four up to where she is now. The burden on the hands of the Pastor is big since he has his two children in secondary school and one in the university under the parallel programme. Effie's siblings are 4 and are in primary school.

She did her KCPE at St. Gabriel's Songor Academy in the year 2013 and scored 385 out of 500 marks. She was admitted to St.Mary's Lwak Girls High School in 2014 and she is currently in form two this year.



Effie has shown great improvement academically in form one after improving from position 89 out of 341 in term 1 to position 22 out of 341 in term 3. She has four siblings who are all in primary school.

She was selected for the WD scholarship by NCCK Nyanza Region through a competitive process

#### ABDON - WD



Abdon was born in 2000 from Sotik district to Mr. Moses K. C. and Mrs. Joyce C. C. Abdon is the forth born child to the family of eight children. He attended Kisabei Primary School from standard one to class six where he moved to Kipajit primary school to join class seven where he sat for his K.C.P.E Examination and got 379 out of 500. Abdon was called to join Kapyanga High school which is a national school category where for him to be able to access admission several harambees were organized to raise funds for his form one admission which was a struggle.

With eight children, my family is over burdened with many

challenges and it is only by the grace of God that he has managed to put through secondary education three girls thanks be to God through thick and thin. My family is a peasant farmer whose only survival is derived from casual laboring as we only access 0.1 hectares which is agriculturally insignificant for crop production. Briefly, the family is very much economically disadvantaged apart from Abdon, my family has four other children who are in primary school.



#### Grace - WD

Grace is a third born in a family of five. She was born on March 2001. Her father passed away when she was in class three and now lives with her mother who does casual work to sustain the family.

Grace and her elder brother who is in Emale School totally depend on their single mother for school fees. The burden so heavy for their mother, a peasant farmer, who has to take care of her other children in primary school.



She managed to score 381 marks in KCPE which she sat at Baraka Benchmark Academy where she was

sponsored by the Director of the school for two years. Grace was admitted in Precious Blood Secondary School-Kilungu.

She is well behaved and her performance is above average. She is determined to achieve her goal in life. Lack of school fees has contributed to poor performance in the school. Given sponsorship she can improve in her class work performance.

She was selected for the WD scholarship by NCCK Lower Eastern Region through a competitive process

#### RAMAH - WD

Ramah was born on 18<sup>th</sup> December 1999 in Tigania West District Mituntu Location Tigania West Sub-County, Meru County. She is the 1<sup>st</sup> born in a family of three. Ramah was born to a 45year old father who is a peasant farmer and a 40 years old mother who is a housewife.

Her family live on a ½ acre of land upon which the parents carry out farming. The little farm produce from the land is hardly enough to feed the family and leave surplus to sell in order to make money to support Ramah's Education.

At times during hostile weather conditions there is little harvest or none. Ramah attained her primary education at CCM Luuria Primary School. However due to lack of school levies she was in and out of school in very many times. With the help of the teachers who always encouraged her, she was able to sit for KCPE in 2013 and scored 391 out of 500.



Ramah joined Kaaga girl's high school in 2013 through the fundraiser that was done by her parents with the help of friends, neighbors and relatives.

Ramah is a very bright student who was awarded Certificate of merit being the Best Girl from Public primary school in KCPE 2013 in the year 2014 during Tigania West District Education Day.

Ramah is now in form two and working very hard to achieve her goal to be a Neuro-surgeon. She is above average academically, of good character, a Sunday school teacher and an active member of her church.

After a very thorough and investigative interview Ramah was recommended for NCCK Scholarship award by the Regional Committee, Upper Eastern Region.

#### Wycliffe - WD



Wycliffe was born on 11<sup>th</sup> December 1998 at Mbeere North Sub-county of Embu county. He is an only child from a single parent family. The mother is a peasant farmer who has no land of her own. In addition, the area is semi-arid and crops rarely do well thus aggravating the situation. Wycliffe has had a lot of difficulties during his time in school due to lack of basic necessities and school fees even when he was in primary school.

In the year 2013 he sat for KCPE at Minimax Academy where he had been sponsored by the school due to his excellent performance and despite all odds, he scored 413 marks that enabled him to be admitted at Moi High School – Mbiruri a National school.

Many are times when he is out of school due to lack of school fees. He has been performing quite well in form 1 in spite of his many challenges. He is currently being assisted by County Constituency Fund (CDF) and well wishers hence funding for future remains bleak. He has great potential and will do better if he is able to concentrate in school. He was recommended to the scholarship by his Church, the Anglican Church of Kenya.

He was selected for the WD scholarship by NCCK Central Region through a competitive process

Maurice was born on 8<sup>th</sup> July 1999 at Dandora Location. Maurice has both parents but they live in the slum set up and they don't have jobs to sustain the family and their children in school.

Maurice sat for his KCPE at Pap Nyadiel Primary School in Siaya where he lived with the mother and attained 391 marks and got admitted at The Prestigious Nairobi School. Through harambee from wellwishers and CDF, he was able to secure his place at Nairobi School. He later moved to live in Nairobi with his dad.



Nairobi School Scholarship office has had concerns about Maurice who has not been in school due to lack of fee and his performance is going down with time. The boy spends a lot of time at home due to lack of fee. The school has recommended him to the Regional office as they were concerned that he will drop out of school.

Maurice is a member of PCEA Brigade and has been baptized in PCEA.

The Nairobi Regional office feels that this boy is bright and needy even though he has both parents alive he might drop out of school anytime. He has huge balances at Nairobi School.



Brian was born on 1<sup>st</sup> November 1998. He has both parents and is being supported by the father who works as a casual labour. Her mother was involved in a fire accident where she was burnt 40% of her body. The family has used all the little resources to treat and sustain her in her condition which is not good and needs a lot of care financially and home support also the children.

Brian sat for his KCPE in 2012 and attained 383 marks to be admitted at Kangaru School.

With the Support of the ArchBishop of NICA, resources were mobilized for his admission at Kangaru School and financial support from well wishers has now been a challenge to the family. Brian is currently dropping academically due to absenteeism in school. He is faced with huge balances in

school yet he is a bright student who can perform well if he settles down.

The ArchBishop Marete and NICA have been supporting the family with funds that is now not sustainable. They recommend that the boy receives assistance from NCCK though they will continue to assist. The Regional office has forwarded this request for Brian. Brian is currently in form three and had applied last year.

He was selected for the WD scholarship by NCCK Nairobi Region through a competitive process

#### **GLEN - WD**



Glen was born on 30th August 1999 as a 3<sup>rd</sup> born child in the family of 39 yrs old Virginia Ngina single parent in Vihiga County. His mother is a peasant farmer.

He sat for his KCPE at Kaimosi Friends Day Primary School and attained 385 marks. The little income that the mother raises from the farm is not sufficient to meet their basic needs and pay his school fees.

In spite of the challenges he has faced in life, Glen is confident that education will enable him to change shape his future to be able to assist his mother.

NCCK Western Regional Committee recommended him for the WD scholarship because of his promising performance, courage, humility and the needy background.

#### **MACSYLVIA - WD**

Macsylvia is the first born in the family of four. She was born on 7<sup>th</sup> march 2000 in Keiyo south district,Kabiemit location. She is a member of the Reformed Church of East Africa. She sat for KCPE exams and scored 356 marks out of 500 marks at Kapchebelel primary school. Her mother Cynthia Kipsang is a single mother who entirely depends on a small hired portion of land to cater for the needs of the family. They live with Macsylvias Grandparents home. In this culture, a woman cannot inherit land hence they do not have any portion from the family land which they could use for their upkeep.

Macsylvia has been subjected to casual jobs to help her mother raise enough funds for her and also for the family's upkeep. While in primary school, she dependent mostly on the teachers who assisted her to meet her basics and also sustains her at school sometimes.

As much as her mother has tried to earn some income from the family farm, this has brought wrangles between her and her brothers who feel she is taking their inheritance away from them. Macsylvia is a polite student and very hardworking in school and also very obedient. Her performance has been dropping which could be attributed to absenteeism.

She is academically promising and has potential to do better if her education is not interrupted too frequently. The church has indicated that they know the family and they have been giving them frequent support.

#### **MAGRET - WD**

Magret was born on 1<sup>st</sup> June 1998 in Tranzoia county,Kinyoro location. She is the sixth born on a family of ten. She is a member of KETC Church. Her father, Fredrick Andiema is a village elder and her mother Regina Chepus is a housewife.

They own a half an acre piece of land which has not been cultivated due to lack of farm materials. Even though they are ten in the family, Magret is the only one in school. The others have dropped out of school due to school fees.

Completing her primary school education was a challenging task. Most of the time she had to go without food and also walk barefoot to school. Doing her homework in the evening was a challenge due to lack of paraffin and also the house chores she had to run after school. However, she managed to score 298 marks in KCPE. Her determination for education didn't stop there despite the challenges she encountered. She managed to join form one in Nakami Girls High school although she is out of school most of the time due to school fees.

#### MATILDA - WD



Matilda was born on 19<sup>th</sup> June 1999 in Tana River County. She is a member of Kongowea Methodist Church. She is the 1<sup>st</sup> born in a family of four children. The other siblings are still in lower primary. The parents moved to Mombasa in search of job when she was young. Since then the family has been staying in Mombasa County. Her father, a sales man earns about Kshs 5,000 every month. Her mother is a house wife

Matilda went to Bashir primary School and scored 373 out of the possible 500. She got a place at Buru Buru gilrs high school but the family could not raise the school fees which was more than Kshs 100,000 per year. Instead they opted to send her to Kombeni girls secondary school. The father's salary is not enough to pay school fees for her as well as taking care of the other siblings.

Her performance is good and she achieved an average of grade A- in Form one; which has earned her some bursaries from the school. She is of good character and hard working as recommended by her school principal and the church. She is well disciplined and hardworking with leadership qualities that if

assisted, can do wonders and achieve her dream. The Church and School are very clear that she is needy and obedient.

#### INTRODUCTION





The aim of writing this letter to you is to give a vote of thanks for getting concerned with




