William and Nancy Budd Scholarship Fund 2012 Annual Report

Highlights in 2012

- The major development of 2012 was the decision to hand over leadership of the Budd Fund to the next generation. At the Board meeting on August 6, 2012, the Board agreed to continue the Budd Fund rather than wind it down. Bill Budd was elected to succeed Daniel Ritchie as President and Emily Baillos to succeed Michael McCarthy as Treasurer. David Budd was elected to the Board as well. The Board agreed to a transition period during which Daniel and Michael would continue to manage the Fund's affairs and finance until the Budd family established new bank accounts and other hand-over arrangements.
- Ten new students were welcomed in 2012, one from each of the nine provinces in Kenya and one from the Kinyoro Primary School in the Trans Nzoia District of Western Province. The biographies of the new students are attached. With these new students, the Budd Fund has supported 114 students since inception in 2000.
- A total of 44 students were financed in 2012, 28 in secondary school and 16 in post secondary education—university level, technical training and teacher training. A list of the students supported in Forms 2-4 (10th grade through 12th grade) and post graduate studies, and the expenses for each student, are attached. The total is three less than in 2011.
- We contributed \$20,000 to the NCCK Scholarship Program in 2012, the same amount as in 2011. Expenditures totaled Kshs. 677, 886 (about \$8070) for secondary school scholarships, Kshs. 481,995 (about \$5738) for post-secondary and 116,420 (about \$1385) for administrative costs, including the student retreat in December 2012.
- The average cost per student in 2012 was \$288 for secondary school, the same as last year but down from about \$400 in 2010, probably reflecting the government's commitment to make secondary education free over time. The average payment for post-secondary was \$358, slightly less than the average of \$400 in 2011.

• Student achievement continued to be outstanding. The 2008 cohort of students sat from their secondary school exams in 2012. The results are shown in the table below. Grades or A to B- means eligibility to pursue higher education.

- The Reserve Fund, established in 2010, and administered pro bono by Doug Platt and invested in Ameritrade, increased in value by \$7,206 in 2012, reaching \$58,936 at December 31, 2012. The Budd Fund Balance Sheet and Profit and Loss Statement at December 31, 2012 are attached.
- Grace Muthungu and Gladys Ndugu of the National Council of Churches of Kenya continued to administer the Budd Fund with skill and dedication.
- The Ninth Annual Meeting of the Budd Fund was held on August 6, 2012 at Encampment Forest Minnesota.

His mother is a business lady who is also a single parent and her financial resources cannot adequately meet his needs. Rox is a partial orphan having lost his father 8

years ago. He is a bright student and is currently in form two at Maranda high school. He has been also very active in Sunday school activities and was made a communicant in the church. Rox was recommended by the Regional Committee, Nyanza Region because he is a bright and obedient student whom if given opportunity is capable of excelling.

FRANKLINE NYANDORO MAKORI – WD/02/12



Frankline was born on 24th October, 1997 being the 1st born in a family of three. His father lost his job and Frankline encountered a lot of fees challenges in primary school and had be in and out of school but by God's grace he managed and performed in school which enabled him to score 392 marks out the possible 500. He is a member of ACK.

MARGRET KAVAVU MUTETI -WD/03/12



Born in 1996 in a family of two, Margret got 382 marks in KCPE and was admitted in Machakos Girls high school. Her mother passed on and was left under the care of their father who is a peasant farmer. Her fees to Machakos girls was raised by well wishers and relatives after they saw her good KCPE results and noted her academic potential. However, she is in and out of school most of the time as the well wishers do not pay her fees consistently.

CAROLINE NKATHA – WD/04/12



Caroline was born on 29th August 1996 in Meru Central District. She is the first born in a family of four. Caroline is born to a 40 year old father who is a peasant farmer. She hails from a single parent family. Her mother passed on and Caroline and her three siblings were left under the care of their father and a step mother.

Together with her family they live in a Quarter an acre of land upon which her father and her step mother grow very little food crops which is not enough for their food and meet their other basic needs.

Caroline completed her primary education at MCK Wesley Boarding Primary School in 2010 with a lot of challenges, after her mother's death. His father would supply cabbages to the school that would cater for her fees. She scored 380 marks and joined St. Mary's Girls High School. She has been in and out of school for lack of school fees as her father's income is

not enough to provide for basic needs and pay school fees for her and other siblings. She is usually affected by frequent gaps created when she has to go home for fees. After a very thorough investigative interview Caroline was recommended by the Regional Committee, Upper Eastern Region for a scholarship award. Caroline is well behaved and a bright student and hardworking.



EVAIDAH WAITHIRA KARIUKI – WD/05/12

Evaidah Waithira Kariuki was born on 12th September 1997 in Nyeri district. She is the fourth born in a family of five children . Two of her elder siblings managed to finish secondary school with a lot of difficulties but they lacked funds to join colleges. The other one is a casual worker in a construction firm while the last born brother is in primary school . The father abandoned the family in the year 2001 and from then, their mother has been struggling solely. The mother is a casual worker who does menial jobs like washing

clothes in order to meet the basic needs for the family and on average raises about kshs.3,000/- per month.

While in primary school Waithira faced many challenges such as lack of school uniform, lunch and learning materials but her teachers supported her because she was very hard working and disciplined girl. Despite the many difficulties she excelled in her studies and was the best girls in her school in the year 2010 with 396 out of 500 marks - KCPE and she was admitted to State House Girls' High School. She is determined to make the best of her education and create a better future for her family and later give back to the society. When Joining form 2 it was an uphill task because she did not have the slightest idea where the fees and all the items requested by the school would come from. Their mother conducted a fundraising and by God's grace the money to join form one was raised. Waithira is determined to work hard if offered the sponsorship so that she can complete her education.



DICKSON KABOCHI WANGARI- WD/06/12

Dickson Kabochi was born on 23rd 09, 1996 in Kabete. He sat for his KCPE at Kabete vet lab primary school and scored 380 marks. A 2nd born in a family of three and a single parent who has no permanent job. The mother is struggling to pay his fees since he has a twin sister who is in form two yet his elder sister also needs to join college. The student is a top performer given a chance he will do much better.

The Regional office recommends that he be considered for the scholarship to enable him and the twin sister complete their education.

LORRAINE REGINA NABWIRE – WD/07/12



Lorraine was born on 21/4/1996 as a first born child in the family of 36 yrs old Everline Odaba who is a single mother. The father abandoned his family of four children. Lorraine's mother is a peasant famer from Busia District.

She sat for her KCPE at Moody Awori Primary School and attained 401 marks. She joined Limuru Girls High School which is a national school. The prospects of Lorraine excelling in her KCSE are very high since the school reputation is exemplary. Currently Lorraine has maintained good performance with a mean grade of A- that is one of the main reasons that made the NCCK WesternRegional Committee to recommend her for the scholarship.


NICODEMUS KIRWA – WD/08/12

He got a place at Lenana school where he's currently in form 2.His academic performance has been very promising and if helped to stay in school he will perform much better.
